Memorandum of Understanding

This Memorandum of Understanding is entered on 09/07/2021 ("Effective Date") by and between **Edunet Foundation** having its office at A-11- 1105, Arcadia South City 2, Gurgaon 122018, India (hereinafter referred to as "Edunet"); and,

JSPM's Bhivarabai Sawant Institute of Technology & Research, Wagholi, Pune. having its address

JSPM'S RSIOIR (hereinafter referred to as "Institution").

Whereas, Edunet is a non-profit organization with multiple programs, sponsored by government and corporate entities, that are offered free to learners across the education spectrum, including but not limited to the Tech Saksham Program (www.techsaksham.org) and SkillsBuild (www.skillsbuild.org).

Whereas, Institution is a premier institution with the following details:

Established (year):	2009
Recognition, NAAC rating, ranking:	B++
Vision:	To bridge the gap between Industry & Academic

And whereas, the Parties seek to collaborate with each other to mutually complement their synergies and to jointly work on building capacity of learners through one or more of the programs managed by Edunet.

Now therefore, this **Memorandum of Understanding** (hereinafter called "**MOU**")witnesses the following.

- 1. Term and termination:** This MOU is valid for an initial term of 5 years from the Effective Date. It can be extended by further periods, as agreed to by the Parties from time to time. Either Party may terminate this MOU by giving the other minimum 30 days' notice. The MOU will be deemed terminated at the end of the notice period or after completing all ongoing activities so that the beneficiaries (learners and teachers) are not negatively impacted, whichever is later.
- 2. Non-binding nature of this MOU:** The MOU is not binding on either Party and each is working with the other out of sheer good-will and for the benefit of the learners.
- 3. Each Party is responsible for its own costs:** Both the Institution and Edunet will independently manage their cost towards fulfilment of obligations under this MOU.
- 4. Single Point of Contact (SPOC) for program co-ordination:** Both the Parties shall appoint a suitable person who will serve as a single of contact on all matters related to program rollout. Individual learners and teachers may be in touch with corresponding trainers, mentors, advisors and peers during program rollout but all matters related to the execution of this MOU shall reside with the SPOC.
- 5. Society for Inclusive Education (SIE):** This is a student led initiative managed and supported by Edunet, that seeks to provide ubiquitous high quality learning opportunities to underserved communities through government and private schools/colleges around India. The Institute will set up a chapter of Society for Inclusive Education on its campus. This chapter will make Edunet programs available to local

underserved institutions and/or student communities through community work, classroom sessions, fund raisers to purchase equipment and free learning platforms. Office bearers will be chosen by the Institute in the first year. They may be either nominated or elected second years. The SIE chapter will have members from within the local student community who are willing contribute some time towards betterment of society. All members of SIE chapter at the Institution will be issued with appropriate certification that will help them meet their CAS/Community Work/SUPW requirements.

6. **Program Calendar:** The SPOCs from both Parties will work with their respective internal stakeholders to develop a calendar for the program(s) rollout at the start of every quarter. This calendar will then be synchronized and published for use by everyone.
7. **Responsibilities of Edunet and/or its program sponsors/partners:**
 - a. **Orientation sessions:** Edunet will conduct orientation sessions for learners and educators, at a mutually agreed schedule, to onboard them onto the program(s).
 - b. **Program materials:** Edunet will share all program materials with the institution and/or learners as required. All sharing will be online and/or through electronic media.
 - c. **Face to face, instructor led sessions:** For learners in the Tech Saksham Program, face to face ILT sessions will be organized on campus and will be delivered by Edunet Trainers to program beneficiaries
 - d. **Online instructor led sessions:** These sessions may take the form of webinars or mentoring workshops or technology bootcamps or innovation camps or career readiness workshops that will seek to assist learners in their career goals. These programs will be organized regular as per a regular calendar, published online and will be conducted by Edunet team members or program sponsors or external stakeholders as appropriate.
 - e. **Interaction with Industry experts:** Edunet will bring industry experts to the Institute to drive engagements with students through seminars/webinars or project mentorship.
 - f. **Online platform availability:** Online platforms for each of the programs of interest to the Institution will be made available to it. Links for these platforms will be made available to the Institution in a timely manner
 - g. **Assessments:** Edunet will conduct assessments, as required, for its programs prior to certification by Edunet and/or its industry partners and/or participating government agencies.
 - h. **For programs with career paths:** Edunet will provide linkages with local and regional industry, government and the local start-up ecosystem (incubators etc) that will help learners with gainful employment and/or entrepreneurial opportunities. Interactions will be encouraged in terms of classrooms sessions, workshops, internship opportunities, career opportunities and entrepreneurship opportunities.
 - i. **SIE support:** Edunet will support the SIE chapter in the Institute with all support required. A separate program manual and guidelines will be sent to the SPOC.
 - j. **Updates:** Edunet will keep Institution management updated with the progress of the program(s)
8. **Responsibilities of Institution:**
 - a. **Learner identification:** Institute will identify learners, volunteers and instructors who may participate in one or more programs offered by Edunet.
 - b. **Support with orientation sessions:** Institute will support Edunet conduct orientation sessions for all stakeholders.
 - c. **Publication of program calendars and goals:** Institute will publish, on a quarterly basis, a program calendar for all its participants.
 - d. **Support with computers labs and classrooms:** Institute will make its labs available to learners. It will make classrooms and/or audio-visual equipment available for face to face sessions, whenever required.
 - e. **Support with attendance:** Institute will ensure that program participants enthusiastically

- participate in chosen programs, with minimum attendance as agreed between the Parties.
- f. **Support with assessments:** Institute will ensure that assessments carried onsite are proctored and professionally managed.
- g. **SIE chapter:** The Institute will support the SIE chapter, led by its students, to the extent possible.
- h. **No fees:** Institute will not charge any extra fees from learners for participation in Edunet programs.

4. To suggest some specialized courses on latest technologies to be inculcated in the Autonomy curriculum and can be implemented jointly at UG/PG level.
5. To carry out some research projects jointly with the help of the expert faculties available with JSPM's BSIOTR.
6. To establish the Centre of excellence to make JSPM students industry ready.
7. To allow use of JSPM's BSIOTR resources including infrastructure, equipment, facilities and domain expertise of faculty for joint research based projects.

TERMS AND CONDITIONS:

1. RELATIONSHIP :

- 1.1 MOU is the collaboration between two parties for mutual benefit.
- 1.2 MOU stands valid for **Five years** from the date of agreement. The collaboration can be terminated from either side with a notice period of one month.
- 1.3 MOU will be renewed after 5 years depending on the performance and work satisfaction by both the parties.
- 1.4 Both parties shall work in synchronism to ensure the successful completion of collaboration.
- 1.5 Both the parties shall provide adequate support and facilities to the concerned students with mutual understanding.

2. OBLIGATION :

- 2.1 There shall be no obligation on any party to compensate the other in any manner or to make any claim.
- 2.2 Each party shall meet the expenses as mutually agreed.
- 2.3 Each party shall respect the others intellectual property (I.P.)

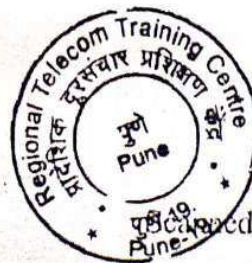

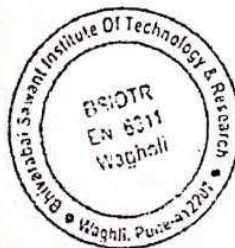

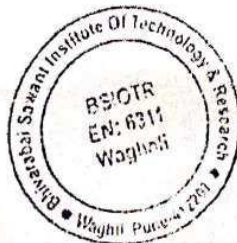

12) Term and Termination:

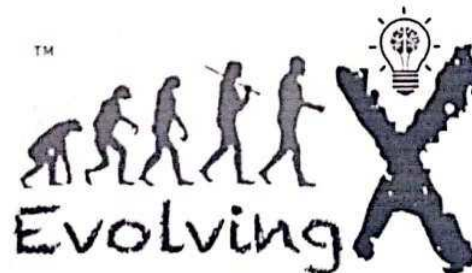

EvolvingX Services (OPC) Private Limited, a company formed under the Companies Act, 2013, with its registered address at CS NO 3263/1/A, NEAR RAJWADA, KURUNDWAD SHIROL Kolhapur, Maharashtra, India – 416106, **(Operating from Pune, Maharashtra) the First Party** represented herein by its authorized signatory, CEO & Founder - Mr. Amol Purandar Nitave (**Name of Competent Authority / Representative**) (hereinafter referred as '**EvolvingX**', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in- office, representatives, employees, administrators and assigns).

AND

JSPM's Bhivarabai Sawant Institute of Technology and Research, Wagholi, Pune, the Second Party, and represented herein by its authorised signatory and representative **Dr. T. K. Nagraj, Principal** (hereinafter referred to as "**INSTITUTION**", company which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, employees, representatives, administrators and assigns).

(**EvolvingX and INSTITUTION** are hereinafter jointly referred to as - "**Parties**")

WHEREAS:

- A) EvolvingX is a **CAPACITY BUILDING & YOUTH EMPOWERMENT PARTNER** named: EvolvingX Services (OPC) Private Limited and is the subject matter expert in Training & Consulting - educational services.
- B) Both parties, **EvolvingX & INSTITUTION**, believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Empowerment Programs through Skill Based Training, Strategic Consultation, Education and Research.



- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest;
- E) The **INSTITUTION** is engaged in Education, Skill Development, and R&D Services in the fields of **Higher & Technical Education, Management & Professional Courses, Employability, Entrepreneurship Development, and related fields**

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

1. Both Parties are united by common interests and objectives to empower youth / students, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institutions** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all non-confidential information that may be relevant to secure additional opportunities for one another. It is recommended that **INSTITUTION** should use own infrastructure to reduce the operational expenses for any event (in-house) being hosted by **INSTITUTION**.
2. **EvolvingX & INSTITUTION's** co-operation will facilitate effective utilisation of the subject matter expertise of EvolvingX and intellectual capabilities of students at **INSTITUTION**, providing significant inputs in developing suitable



eco-systems, keeping in mind the needs of the industry, to the INSTITUTION.

3. The general terms of co-operation shall be governed by this MOU. Both Parties shall cooperate with each other and shall, as promptly as is reasonably and Financially practical, and in order to encapsulate a case-to-case basis understanding of such financially practical cooperation enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. Nature of activities:

- A. **Type 1:** 'Completely Free for **INSTITUTION**', OR 'EvolvingX would arrange all expenses, if any'
- B. **Type 2:** 'Only Operational Expenses & Logistics for the **INSTITUTION**, if any' (Example: travel/stay/stationary/course material/venue set up, etc.)
- C. **Type 3:** 'All expenses would be arranged by the **INSTITUTION**' (Training cost, operations & logistics)



Both parties will decide on the nature of the intervention and commence once they mutually agree to it in writing prior to such intervention. In case of type 2 or 3, Both parties will have mutual consent on the commercial nature of the specific intervention and agree in writing (email, letter, notice, or any other digital medium) before commencing any commercial/non-commercial engagement pertaining to the scope of the MoU.

CLAUSE 3 INTELLECTUAL PROPERTY

- 3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.
- 3.2 Both parties will respect each others Privacy and IPR Policies without any violation. In case of any violation of IPR, the MoU would be terminated immediately.

CLAUSE 4 VALIDITY

- 4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms during **2nd October 2020 to 31st March 2023**, the **EvolvingX INSTITUTION**, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **CAPACITY BUILDING & YOUTH EMPOWERMENT PARTNER**, the **EvolvingX** after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU.
- 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations

Neither Party is authorised to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.



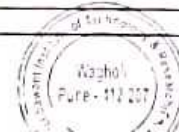

On **Aarogya Setu**

On 2nd April 2020, India launched Aarogya Setu mobile App for helping augment the efforts of limiting the spread of COVID19, with an objective of enabling Bluetooth based contact tracing, mapping of likely hotspots and dissemination of relevant information about COVID19. The App has over 114 million users as on 26th May, which is more than any other Contact Tracing App in the world. The App is available in 12 languages and on android, iOS and KaiOS platforms. Citizens across the country are using Aarogya Setu to protect themselves, their loved ones and the nation. Many youngsters also call Setu as their Bodyguard. The key pillars of Aarogya Setu have been transparency, privacy and security and in line with India's policy on Open Source Software, the source code of Aarogya Setu has now been made open source. The source code for the Android version of the application is available for review and collaboration at https://github.com/nic-delhi/AarogyaSetu_Android.git. The iOS version of the application will be released as open source within the next two weeks and the server code will be released subsequently. Almost 98% of Aarogya Setu Users are on Android platform.

The Government of India, by opening the product design and code, has also demonstrated its strong commitment to contributing to the global good. India is keen to share learnings from our approach to technology to fight COVID-19 and make the benefits of the solution available to the rest of the world and any government can use it for fighting the pandemic. Together we can, and we continue supporting the doctors and frontline health work in helping fight this pandemic.

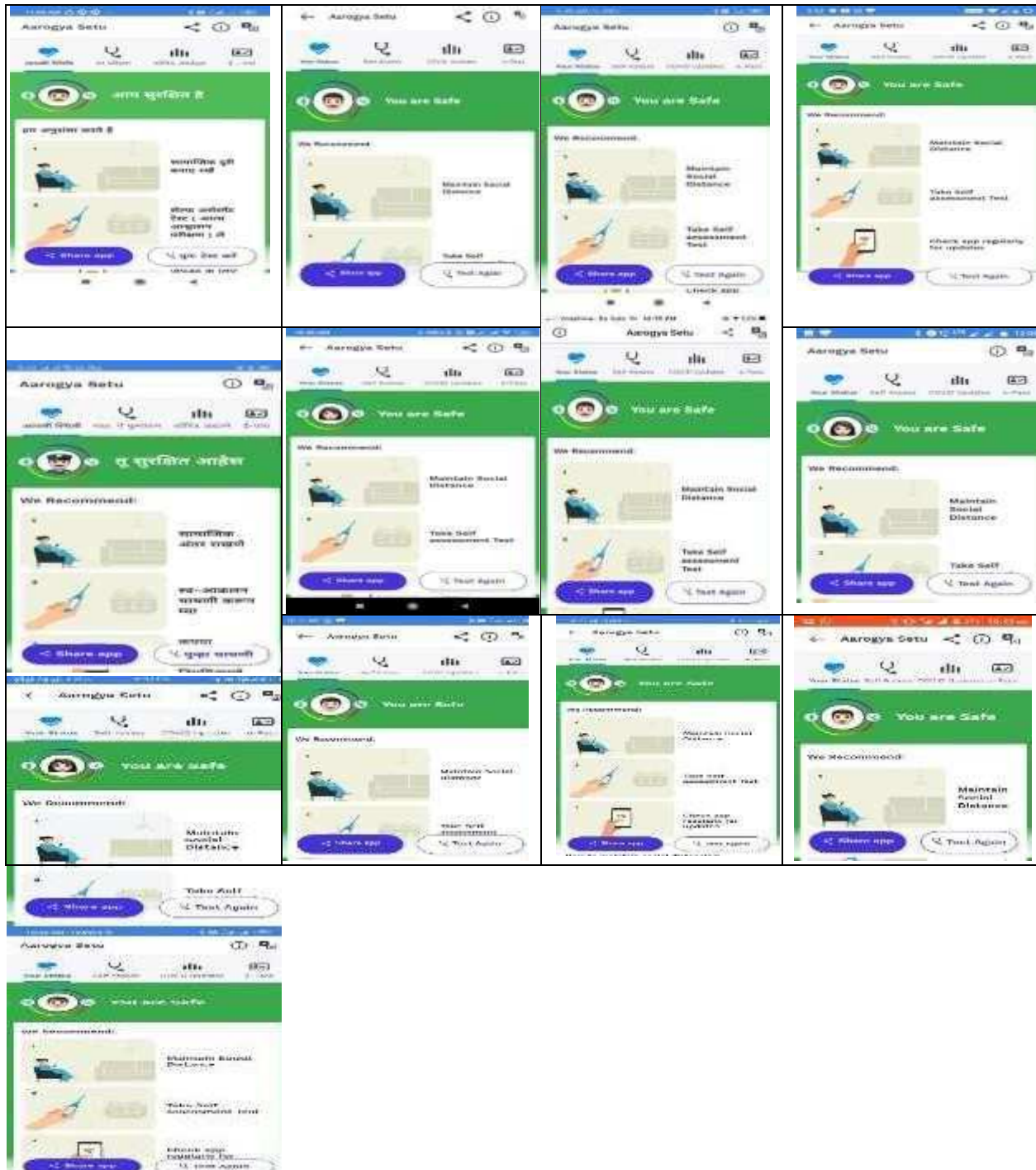

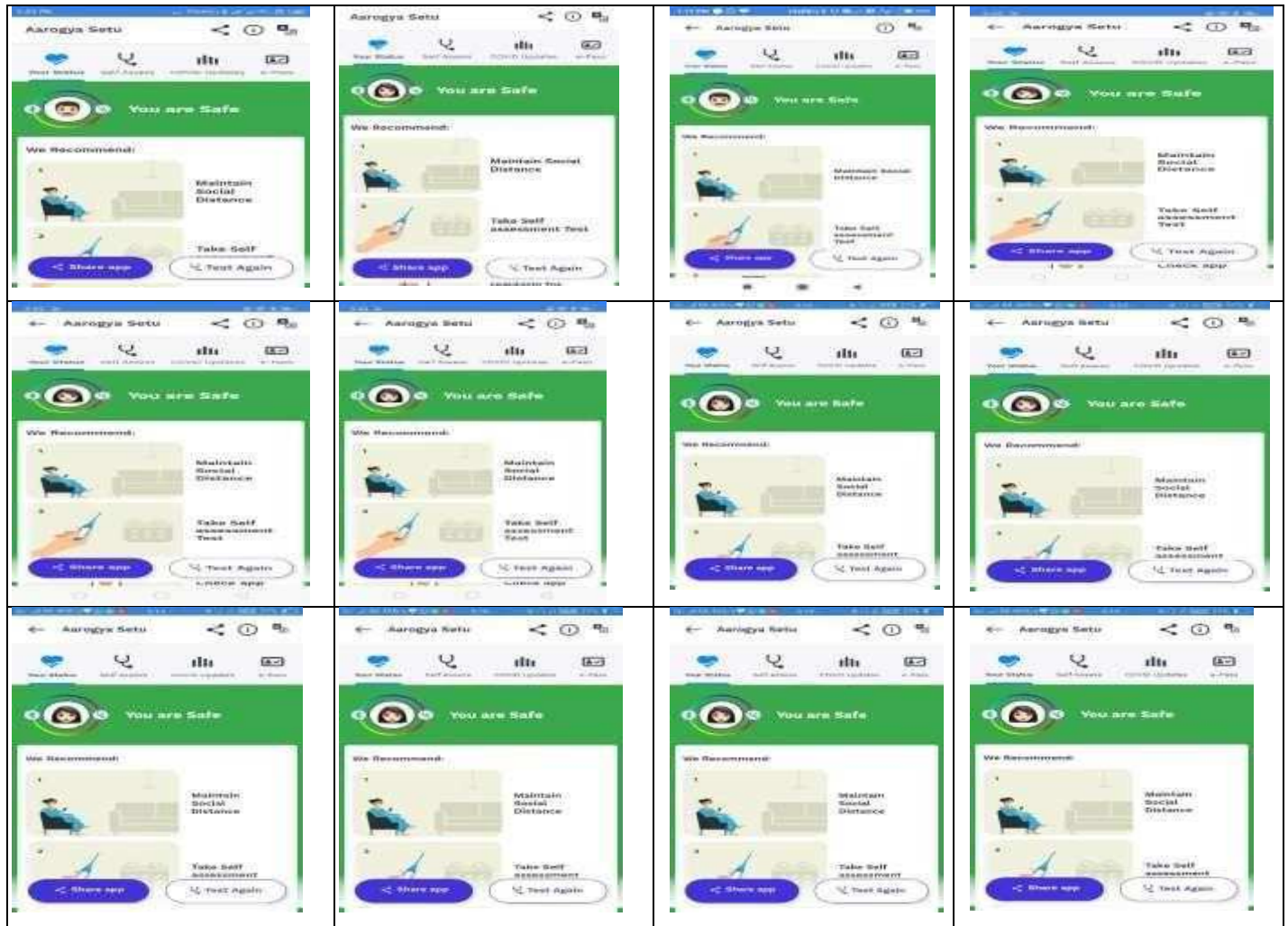

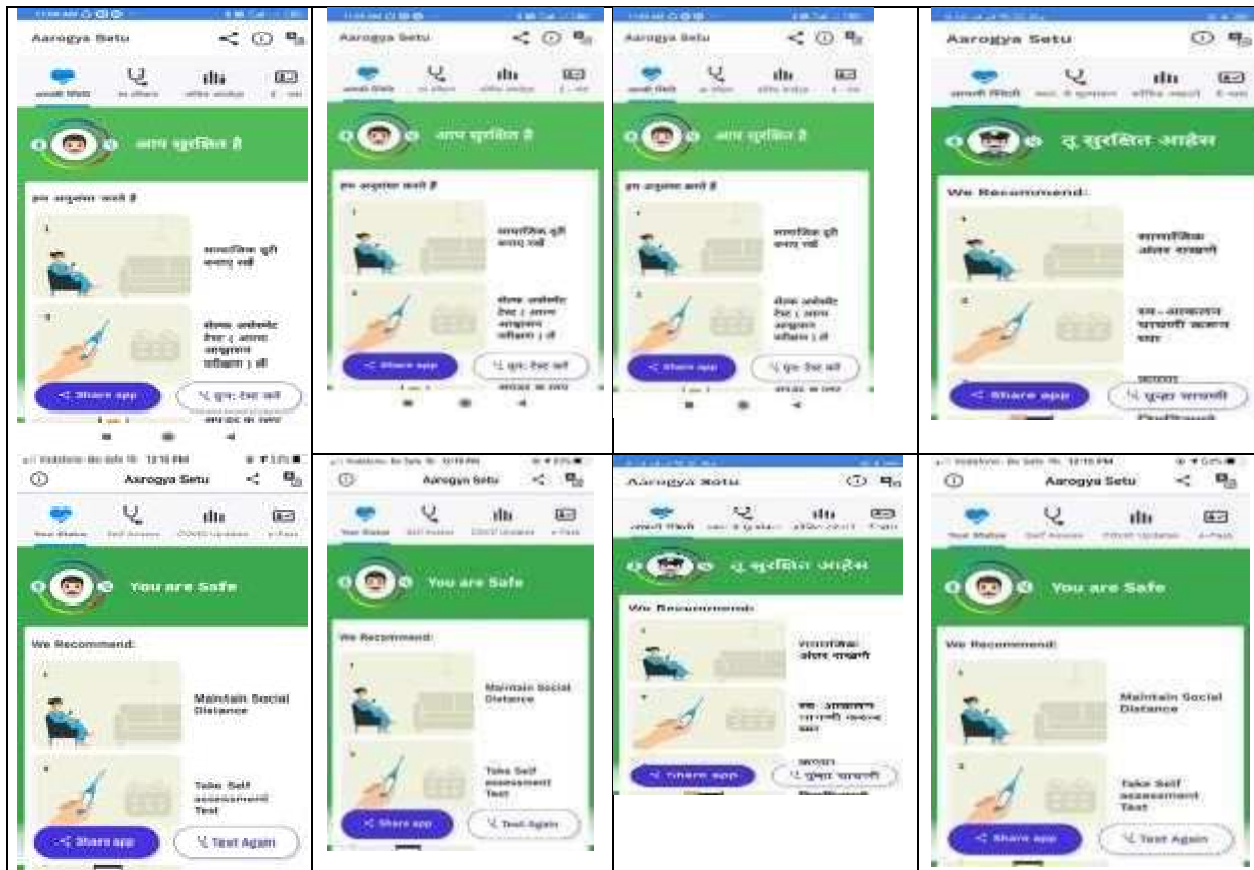

Integrated Govt. Online training portal for COVID 19

India is fighting against covid-19 Pandemic and India's first line of workers is already engaged in COVID relief and doing commendable job. However, a larger force will be needed to replace the first line and to tackle the exponential or geometric increase in positive COVID cases in the subsequent stages of the pandemic.

Accordingly, to take care of the training needs of the frontline workers, the Government of India has launched a training module for management of COVID-19 named 'Integrated Govt. Online training' (iGOT) portal on Ministry of HRD's DIKSHA platform for the capacity building of frontline workers to handle the pandemic efficiently.

Courses on iGOT have been launched for Doctors, Nurses, Paramedics, Hygiene Workers, Technicians, Auxiliary Nursing Midwives (ANMs), State Government Officers, Civil Defence Officers, Various Police Organisations, National Cadet Corps (NCC), Nehru Yuva Kendra Sangathan (NYKS), **National Service Scheme**, Indian Red Cross Society, Bharat Scouts and Guides and other volunteers.

The training contents of the course include Basics of COVID, clinical management, ICU care management, infection prevention and care, usage of PPE, quarantine and isolation, training for NCC cadets, management of COVID 19 cases, laboratory sample collection and testing, psychological care of patients, paediatric care in COVID, pregnancy during COVID, etc. The new learning content is being regularly added to the modules.

The platform provides the training module on flexitime and on site basis so that the COVID response can be delivered at scale for the workforce needed to tackle the pandemic.

Our NSS volunteers also take part in it. So many volunteers register Online training' (iGOT) portal on Ministry of HRD's DIKSHA platform for the capacity building of frontline workers to handle the pandemic efficiently.
