b) In case of Research Institute, it should be recognized by the University for the subject for which you are recognized as M.Phil/Ph.D. Research Guide.
If the recognition granted by the University to your Research Institute gets over then your recognition as an M.Phil/Ph.D. Research Guide will be treated as cancelled from the date on which the recognition to your Research Institute gets over.

- iii) In case of those M.Phil/Ph.D. Guides whose length of service as a regular faculty is not more than two years, in such cases it is essential for them to take a Co-Guide whose length of service as a regular faculty should not be less than five years and the said Co-Guide should be approved M.Phil/Ph.D. Guide of Savitribai Phule Pune University.
- iv) No fresh M.Phil/Ph.D. 'Research Students' should be registered with M.Phil/Ph.D. Research Guides whose length of service as a regular faculty is not more than two years.


In addition to the above conditions, it is essential to mention the name of 'Savitribai Phule Pune University' in author's address in the Publications made by you and your students.
